

Simpson County Water District NOTICE

Notice is hereby given that Simpson County Water District, 108 Morgantown Road, Franklin, KY 42134, has received notice from White House Utility District of a wholesale rate increase. Therefore, Simpson County Water District has filed an application with the Kentucky Public Service Commission for the purpose of adjusting water rates effective January 1, 2025 as follows:

These rates apply to all customer classifications and are subject to 10 percent penalty if paid after the due date.

The monthly bill for an average residential customer using 4,700 gallons of water each month will increase \$4.09 (or 11.2%) from \$36.44 to \$40.53. The monthly bill for an average commercial customer using 36,000 gallons of water each month will increase \$31.32 (or 13.8%) from \$227.01 to \$258.33.
