WITNESSETH: WHEREAS, the District is now constructing a water line which will pass through
and be located on Owner(s) land; and
WHEREAS, the Owner(s) desire(s) to assist the District by furnishing an exclusive easement and
right of way through and upon said property in view of the benefits to be derived from the construction,
maintenance, and operation of the water line and appurtenants;
NOW, THEREFORE, the Owner(s), for and in consideration of the mutual benefits to be derived
by the parties hereto, and other good and valuable consideration, the receipt of which is hereby acknowledged, do
hereby give, grant, bargain, and convey unto the District, its successors and assigns a permanent, exclusive
easement and right of way for the water line and its appurtenances upon and under a strip of land located in
Simpson County, Kentucky, as shown on the attachment, as filed in the office of the Simpson County Water
District, 523 U.S. 31-W Bypass, Bowling Green, Kentucky, the strip being feet in length, more or less, and
being ten (10) feet wide, and lying five (5) feet on each side of the water line, being more particularly described in
